- I. <u>President</u> Pavilion is reserved for summer picnic 08/22/15. Endurance show 02/20 and 02/21 was staffed by several Board members. Ride pace was discussed. Ride leaders are encouraged to be clear about posted ride pace at each ride so cyclists will develop realistic expectations, including when and how a ride leader will stay back with slow riders.
